Meeting Minutes

Meeting called to order by Randy Auman at 1305 hours

Reading of the minutes of the August 2006 Utah 911 Committee was dispensed.

- After discussion, Chuck McCown moved to approve the minutes. The motion was seconded by Dave Whiteand passed the Committee members' vote unanimously.

Agenda items

Bill Jensen, Dave Spatafore and Sam Saeva reported on the MoU to be executed by Utah State Tax Commission (USTC) and Vonage. Spatafore reported that although Salt Lake City has reduced their surcharge to 61¢ from 65¢, effective July 1, 2006, they have subsequently decided to increase it back to 65¢, beginning January 1, 2007. This will allow Vonage to pay their voluntary in-lieu-of-tax amount of 78¢ x total Utah customers per month. Vonage expects to commence remittance based on collections from customers on October 1.

Dave Spatafore presented information on his ability to consult with, represent and advise the Committee and the State's PSAPs on legislative issues.

- After discussion, Mike Mathieu moved the Committee approve a consulting agreement with Dave Spatafore, subject to review and approval by the State Attorney General's office. The motion was seconded by Gary Lancaster and passed the Committee members' vote unanimously.

Sam Saeva presented 9-1-1 Committee financial information showing all grants written from April 2005 through now. He estimated \$7.9 million has been collected by the 13¢ fund; \$6.0 million is obligated to date on already-approved grants for Enhanced 911, Phase I and Phase II grants, including the grant approved today and \$0.2 million expended on staff and administration costs, allowing \$1.7 million available for future approved grants. After discussion, the Committee accepted the September 21, 2006 financial report.

AGRC's Kelly Green produced and presented an updated statewide map illustrating PSAP level of compliance, grant amount and forecast completion date of grant-funded projects.
